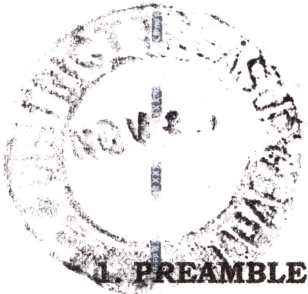

4. Encourage student participation and integrate industry inputs into the academic process wherever feasible.



#### 4.2 Responsibilities of the Industry Partner

## 6. FINANCIAL AND LEGAL NATURE


